12/05/2025	Return signed OR complete Year-End Authorization Form (https://www.surveymonkey.com/r/QKHB8YV).
12/25/2025	PNI & GCP closed - Christmas Holiday*
Last 2025 payroll	Review employee addresses & SSN. All changes should be entered prior to submission. Look at the employee W-2 Preview Report. Reporting > Client Reports > Employee W-2 Report.
Last 2025 payroll	Send Third Party Sick Pay to Support at support@pnihcm.com or support@govconpay.com; You may reach out to Third Party Provider for needed reports in advance of 12/31.
Last 2025 payroll	Enter Adjustments to ensure W-2s are accurate - ALL ADJUSTMENTS NEED TO BE SUBMITTED . Any adjustments past this date will have fees assessed.
12/29/2025	Final approval of W-2 Preview Report. Accessible in Year-End Reports.
12/29/2025	Final requests for W-2 adjustments.
12/29/2025	Request W-2 deferred printing (must be received in writing.)
12/29/2025	Last day for 2025 payroll processing.
01/1/2026	PNI & GCP closed - Happy New Year!*
01/16/2026	ACA - Approve ACA Forms
01/31/2026	W-2s / 1099 forms must be provided to employees.
03/31/2026	PNI•HCM will electronically file 1094 / 1095 information to IRS
