#### PROGRAMS INCLUDE:

#### **GOLD STAR & SURVIVING FAMILY SUPPORT**

Support for Gold Star/surviving spouses and children of Navy SEALs in the immediate aftermath of a loss and in the ensuing years. Assistance is offered for funerals, mortgage, education, dental care and other health and quality of life needs.

### **HOME BASE TBI TREATMENT**

Home Base's Intensive Clinical Program (ICP) for post- traumatic stress, traumatic brain injury or other invisible wounds is offered free of cost to Navy SEALs. In the ICP, SEALs receive close to a year's worth of treatment in two weeks, putting them on a path of success that will be complemented by ongoing care in their home towns. Treatment, lodging, transportation and meals are covered.

#### HONORED SEAL LEGACY SCHOLARSHIP PROGRAM

The Honored SEAL Legacy Scholarship Program awards annual higher education scholarships to children of Navy SEALs. Each \$5,000 scholarship bears the name of one of the more than 100 Navy SEALs that have lost their lives since 9/11.

#### **SEAL LEGACY GRANTS PROGRAM**

The Foundation's grant program is designed to ease the financial burden that can occur as a result of service and includes support for health and medical costs, living expenses, child resiliency and educational needs, and other issues arising from frequent deployments and inherently dangerous work.
